Terms and Conditions

“Aami Goenkar in partnership with **Khar Gymkhana**” has taken the initiative to organise “Goa Festival” in order to bring Goans together with all communities. Our purpose is to promote the small scaled entrepreneurs and to showcase their art, culture, food products and handicrafts in Mumbai. In order to make this event a great success, we request all applicants to observe the terms and conditions given below:

- 1 The applicant will take full responsibility to reach the venue along with their goods in time for the festival.
- 2 Outstation applicants will have to make their own arrangements for accommodation in Mumbai.
- 3 The allotment of the stalls will be done by the organizers and their decision will be final.
- 4 The goods sold at the festival should be of good quality. Any complaint regarding the quality will be directed to the respective seller and he/she will be answerable to the customer.
- 5 Though the organizers will do their best to attract visitors, they do not take any responsibility for unsold goods.
- 6 The applicant will have to arrange for the manpower required at the stall.
- 7 Incomplete forms will not be processed.
- 8 Organizers will endeavour to provide appropriate security at the festival venue. However no responsibility will be taken by organizers for loss of either goods or money.
- 9 Each stall of 2mx2m size will be provided with two tables and two chairs. Each stall of 3mx3m size will be provided with three tables and three chairs. Additional chairs/ tables will be charged extra.
- 10 Each stall owner will have to keep garbage bins in front of their stall separately for dry and wet garbage.
- 11 Each stall owner will be provided 2 electrical points for usage of electrical appliances (Microwave oven, Toaster, , Mixer- Grinder, Induction Hot plates). Usage of refrigerator will be charged extra.
- 12 Organizers will provide fans in appropriate places in the exhibition area. The stall owners requiring additional fan will be charged extra.
- 13 The person booking the stall should use it for self or immediate family member. Transfer or subletting of the stall (either full or part) without organizers ‘ permission is strictly prohibited. Firm action will be taken in such cases.
- 14 Life Members availing discount should utilise the stall for their own use and not sublet to others.
- 15 Stall owners should display the name of the stall/ company with the banner of 6’X2’ (stall of 2m X 2m) and 9’ X 4’ (stall of 3m X 3m) inside and on the front face of their stall only. Banners/Posters displayed outside their stall area will be charged extra.
- 16 While organizers will buy an appropriate insurance policy, the stall owners will be responsible for insuring their own goods and material.
- 17 Applicant should attach the complete list of products along with the application form
- 18 The organizers reserve the right to reject any application without giving any reason.
- 19 The charges are all inclusive(GST not applicable) and for both days of the event.
- 20 Stall owners need to keep proper vigilance to ensure that they are not misled by unwanted elements.
